### **VENUE**

The venue is the Yacht Club Znojmo, Vranovská přehrada, the Czech Republic

### **CLASSES**

The event is for the Star Class

### ORGANIZING AUTHORITY

The Organizing Authority is the Yacht Club Znojmo, in cooperation with the Czech Sailing Association.

### **RULES**

The Regatta will be governed by:

- a) The 2009-2012 Racing Rules of Sailing (RRS),
- b) National prescriptions of the Czech Sailing Association (ČSJ)
- c) The International Class rules of the classes concerned
- e) this Notice of Race,
- f) Sailing Instructions
- g) Notices of the Race Committee and JURY.

In the event of conflict between particular documents, the document listed lower shall prevail. In the event of conflict between languages, the Czech text shall prevail.

### **ADVERTISING CATEGORY**

All boats shall meet requirements as provided in ISAF Regulation 20 – "Advertising code". If a boat/sailboard displays advertising, at least one competitor shall hold a valid Individual Advertising License in accordance with ISAF Reg. – "Advertising code" - 20.4.3 (and section 3 of the Events Regulations – Czech competitors only). Boats may be required to display a bow number and advertising of the event sponsors on the side of the hull.

### **ENTRY AND REGISTRATION**

Competitors will enter the Regatta by completing the entry and registration form at registration, paying the Entry fee and presenting the following documents:

- Czech Sailing Association Competitors License with medical approval no older than one year (only for Czech competitors)
- Documents in accordance with ISAF Reg. 19
- Valid Class Certificate
- The paper (document) about the insurance acording to "Liability for Damage" for this championship
- Individual Advertising License in accordance with section "Advertising category"of this Notice of Race

The entry form shall be signed by the skipper. By signing the entry form s/he agrees to be bound by Racing Rules of Sailing and other documents valid for the regatta.

The entry form of the crew of any underage competitor (under the age of 18) shall be signed by the adult taking responsibility for the competitor. This person also confirms that the buoyancy of the boat and the life jacket of the competitor is in compliance with valid rules.

## **ENTRY FEE**

The entry fee is:  $75 \in$  per boat Star. If you send the entry form until 1. 6. 2011 your entry fee will be  $60 \in$ . The entry fee shall be paid at registration.

### **MEASUREMENT**

The Measurement registration and the Measurement before races will take place at a time stated on the Official Notice Board. Written approval of the Event Measurer is necessary to enter the regatta. A valid Class certificate shall be presented at the Measurement registration. Random Control Measurement may be undertaken of any boat, sails and equipment at any time during the regatta.

### **PRIZES AND CATEGORIES**

The prices was given to the first, the second and the third places in The Czech absolute order and in case the international participation was on one from the first three places then the prices was given for the first, the second and the third places in the international absolute order. One valid race to finish at least and the participation of two crews in the ship class are conditions of valid competition. The finishing of three valid races at least and the participation five crews in the ship class at least are necessary to consider valid championship of the Czech republic.

### **TELEVISION AND MEDIA**

The organizing authority shall have the right to use any images and sound recorded during the event free of charge.

### LIABILITY AND INSURANCE

Competitors will participate in the Regatta entirely at their own risk. The Organizing Authority will not accept any liability for personal damage, injury or death, sustained in conjunction with, prior to, during or after the Regatta. The Organizing Authority disclaims any and all such liability. Each competing yacht shall have valid third party liability insurance with a minimum cover of 9 million CZK.

### **ACCOMODATION**

Accommodation is available at the venue of the event, providing it is booked with the organizers by 1. 6. 2011, otherwise participants have to find accommodation on their own accord.
