1. RULES

- 1.1. The regatta will be governed by rules that are defined in the ISAF Racing Rules of Sailing 2005-2008
- 1.2. The prescriptions of the NA that apply will be posted on the Official Notice Board

2. ADVERTISING

- 2.1. Competitors may display Category C advertising in accordance with ISAF Regulation 20
- 2.2. In accordance with ISAF Regulation 20, boats shall display at all times a sticker with the event sponsor advertising provided by the Organizing Authority

3. ENTRIES

- 3.1. Entries shall be made on the official entry form or through the e-mail form on the Carnival Sailing Week website only. Fully completed entry forms should be received at the entry address no later than 6.00pm on 20th January 2008.
- 3.2. The **Optimist Class** will be divided in three fleets:
 - Red Fleet - All the sailors that in 31st December 2008 have 12 years old or more;
 - Blue Fleet - All the sailors that in 31st December 2008 have 11 years old or less;
 - White Fleet - All the sailors that are learning to sail

4. ENTRY CONFIRMATION

- 4.1. All entries, when accepted, will be displayed on the Carnival Sailing Week website. This display can be considered as a confirmation. This confirmation does not imply confirmation of the reservation of accommodation.

5. REGISTRATION

- 5.1. Competitors and team leaders shall register at the Registration Office at the Regatta Center in Vilamoura, prior to competing in the Carnival Sailing Week. The Registration Office will be open on Friday, 1st February 2008, 6.00 pm to 11.00 pm, and Saturday, 2nd February, 9.00 am to 11.00 am.

6. FEES

- 6.1. The following entry fees (in Euros) will be charged:

10.1. The low point Scoring System, Rule A2, will apply to all Racing
